1. INTRODUCTION

The Board of Directors of Sunsuria ("Board") wishes to announce that the Company had on [27 April 2019] entered into a Memorandum of Understanding ("MoU") with Sinotrans (the Company and Sinotrans to be collectively referred to as "the Parties") to foster cooperation with each other on the basis of mutual rights and obligations regarding potential logistic related business in Malaysia.

2. INFORMATION ON SINOTRANS

Sinotrans is a company listed in Hong Kong Stock Exchange and the Shanghai A-Share Market, duly incorporated and existing under the laws of the People's Republic of China, having its registered address at Building 10/Sinotrans Tower B, No. 5 Anding Road, Chaoyang District, Beijing, China.

Sinotrans provides freight forwarding, shipping agency, bulk cargo transport, project logistics, contract logistics, trading logistics and liner services worldwide. It also provides inter alia, sea/air freight forwarding services, including cargoes collection and delivery, booking, customs, immigration and quarantine clearance and declaration, container vanning/devanning, storage, haulage service, distribution and dispatching, international transit shipment service and etc.

3. SALIENT TERMS OF THE MOU SINOTRANS

The purpose of the MoU with Sinotrans is to support discussion on potential strategic collaboration between the Parties to leverage on each respective Party's advantages and expertise to promote and strengthen cooperation in logistics services, logistics real estate development and other related industries in Malaysia ("Proposed Venture").

Under the term of the MoU, both Parties agreed, inter-alia, on the following:

- (a) to jointly promote logistic related business in Malaysia and South East Asia in line with the "One Belt One Road" policy by exploiting the strategic geographical location of Malaysia, where projects include but not limited to Malaysia-China Kuantan Industrial Park, Regional Logistic Hub in Klang Valley, ECRL Project Logistic and E-Commerce Business;
- (b) to make use of their respective strengths and expertise to jointly promote cooperation in logistics and other industries in Malaysia; and
- (c) to actively explore research and development to promote the realization of cooperation goals through ways including but not limited to establishing joint ventures, cooperation of stock rights and forms of joint mergers and acquisitions.

4. VALIDITY

The MoU shall become effective from the date of the execution of the MoU and shall remain in force and effect for a valid term of six (6) months ("Term"), unless terminated or renewed upon mutual agreement between the Parties.

The MoU is not subject to the approval of the shareholders of Sunsuria or any other relevant authorities.

8. DIRECTORS' AND MAJOR SHAREHOLDERS' INTERESTS

None of the Directors, major shareholders and/or persons connected with a Director or a major shareholder of the Company, have any interest, direct or indirect, in the MoU.
